DECLARATION

In accordance with my wish to stand for election to the Board of Directors, VantageOne Credit Union, I declare that:

- 1. I have maintained the minimum number of shares required for membership in VantageOne Credit Union:
- 2. I meet the eligibility requirements of the Financial Institutions Act or the Credit Union Incorporation Act for becoming or acting as a director;
- 3. I am not an employee of the Credit Union Deposit Insurance Corporation of British Columbia, an auditor of a credit union or a public servant concerned by his or her duties with the affairs of a credit union:
- 4. I am not a corporation;
- 5. I have not been bankrupt in Canada or elsewhere in the last five years;
- 6. I have not been convicted of an offence in connection with the promotion, formation or management of a corporation or involving fraud unless five years have elapsed since the latest of:
 - the expiration of the period fixed for suspension of the passing of sentence without sentencing;
 - (ii) the imposition of a fine; or
 - (iii) the conclusion of a term of imprisonment and probation, if any;

but the disability imposed by this Rule 12.5(g) ceases on a pardon being granted under the Criminal Records Act (Canada);

- 7. I have not been found to be incapable of managing my own affairs by reason of mental infirmity;
- 8. I am not an employee of VantageOne Credit Union or any of its subsidiaries or affiliates;
- 9. I am not the spouse, parent, stepparent, child, step-child, mother-in-law, father-in-law, daughter-in-law or son-in-law of an employee or director of VantageOne Credit Union or any of its subsidiaries or affiliates:
- 10. I am not the spouse of, a director, officer or employee of another credit union (other than a central credit union), bank, trust company, savings and loan association, loan company, deposit taking institution, insurance company or agency, stock brokerage or investment dealer or any other firm, association, syndicate, company, corporation or other business enterprise engaged in or concerned with or interested in, any business or any part thereof from time to time carried on by the Credit Union or by any of its subsidiaries;
- 11. I am a member in good standing of VantageOne Credit Union, for at least 12 months prior to the date on which nominations for the election of Directors are closed pursuant to these Rules;
 - a. A "member in good standing" means a member who, at the date on which good standing is determined:
 - i. Has purchased, paid for and holds the number of Class A Membership Equity Shares required by these Rules;
 - ii. Has maintained at least one account with VantageOne Credit Union that has had activity anytime in the 12 months prior to the date on which good standing is determined; and
 - iii. Is not more than 30 days in arrears in any obligation to the Credit Union;
- 12. I have not been an employee of the Credit Union or any of its subsidiaries or affiliates during the 12-month period immediately before such election or proposed appointment.
